This includes, but is not limited to, mishandling, transit delays, missing and damaged boxes, un-recovered and improper airline disposal of freight, exposure to extreme temperatures, et al. Inspect all packages before departing the airport to determine seen/unseen damages/deaths and immediately file a claim.

I (the applicant/buyer) understand these conditions and the legality of this agreement and agree not to hold Reef Wholesale liable for any loss, for any reason. This applies to claim(s) declined and unpaid by the appropriate airline.

I also will not, under any circumstances, refuse any shipment once the order is placed with Reef Wholesale and shipped. I am responsible for pickup regardless of delays by airlines and will file claims if necessary.

Pictures are necessary to provide credit. Credit issued will be applied on my future order/ orders from Reef Wholesale.

I (the applicant/buyer) am responsible for all shipping charges incurred and will file a claim with the appropriate carrier if any damage or loss occurs. This includes, but is not limited to, mishandling, transit delays, missing and damaged boxes. Inspect all packages before accepting order to determine seen/unseen damages and immediately file a claim with the appropriate carrier.
